



Reduce Your Taxes by Purchasing a Forklift NOW!

Through the Section 179 Expense Provision

We recommend buying equipment for your facility before the end of the year, because the Section 179 deduction limit has more than doubled compared to last year, and Bonus Depreciation has increased from 60% to 100%. That means that you can deduct up to \$2,500,000 for qualifying purchases in 2025. Are you spending more than \$2,500,000? The remaining amount can be deducted through 100% bonus depreciation.

Example:

Spend \$3,000,000 on qualifying equipment:

1. Deduct \$2,500,000 through Section 179
2. Remaining amount: \$3,000,000 - \$2,500,000 = \$500,000
3. Deduct the remaining \$500,000 through Bonus Depreciation

The total 2025 deduction for your equipment purchase is \$3,000,000.
